**LENZING™ Lyocell fibers** are manufactured at this present time using dissolving pulp derived from wood as stated below and can be manufactured at these production sites:

Lenzing (Austria), Heiligenkreuz (Austria), Grimsby (UK), Mobile (USA), Prachinburi (Thailand)

The production sites in Lenzing Austria (LAG) and Mobile (USA) are PEFC CoC and FSC® CoC certified.

Certified fiber is available from these sites after discussion with the appropriate commercial contact.

LENZING™ Lyocell fiber from Prachinburi, Heiligenkreuz, Grimsby, Mobile and Lenzing Austria (LAG) can be supplied as FSC Mix Credit after discussion with the appropriate commercial contact.

Note: Other new sustainable dissolving wood and pulp types may be tested in the manufacture of LENZING™ Lyocell fibers.
